ONE TIME COVID-19 LIABILITY RELEASE WAIVER

(To be completed by all members and visitors)

The World Health Organisation has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person to person through respiratory droplets, the Government has set recommendations, guidelines and some prohibitions which **The committee, officers, representatives, independent contractors, affiliates, successors and assigns of Chichester Rifle and Pistol club of Wellington Road, Chichester PO19 6BB** (the 'Club') adheres to comply.

In consideration of my participation at the foregoing Club and any minor child/children* for whom I have the capacity to contract, I, the undersigned, acknowledge and agree to the following: *(Please tick box as appropriate)*

The designated Range Officer for that day will have final say as to whether any member can participate

I am aware of the existence of risk on my physical person at the venue and that my participation in the activity of the Club may cause injury or illness such as, but not limited to Influenza, MRSA, or COVID-19

I will not enter the club premises if:

I, or any members of my household, have experienced symptoms relating to COVID-19 *(see current symptoms from the NHS website)* within the previous 14 days

I, or any members of my household, have travelled to countries or territories which are not exempt from the current FCO COVID-19 Travel Advisory notices *(see current list from Gov.uk)* within the previous 14 days

I, or any members of my household, have visited any area within the UK that was reported to be highly affected by COVID-19 in the previous 14 days

I, or any members of my household, have been diagnosed to be infected with or by the COVID-19 virus within the previous 30 days

I, or any members of my household, have been advised to isolate as part of the NHS test and trace service with in the previous 14 days

Following the pronouncements above, I hereby declare the following:

I accept that I am fully and personally responsible for my own safety and actions during my participation and I recognise that I may be at risk of contracting COVID-19

With full knowledge of the risks involved, I hereby release, waive and discharge the Club from any and all liabilities, claims, demands, actions and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury or death that may be sustained by me related to COVID-19 while participating in any activity while in, on or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19

I agree to indemnify, defend and hold harmless the Club, from and against any and all costs, expenses, damages, lawsuits and/or liabilities or claims arising whether directly or indirectly from or related to any and all claims made by or against any of the released party due to injury, loss or death from or related to COVID-19

By signing below, I acknowledge that I have read the foregoing COVID-19 Liability Release Waiver and understand its content; that I am at least eighteen (18) years old and fully competent to give my consent; that I have been sufficiently informed of the risks involved and give my voluntary consent in signing this Covid-19 Liability Release Waiver as my own free act and deed with full intention to be bound by the same and free from any inducement or representation.
